1 Application

The application must be made using a separate registration form, which it is to be submitted to Messe München GmbH fully completed and signed. The participation per day is limited to 9 companies. The “first come, first serve” principle applies.

Deadline for application is Friday, March 28, 2025.

Upon receipt of the confirmation of participation from Messe München GmbH, the contract for the company's participation in the transport logistic Campus Plaza comes into effect.

2 Admission criteria

Each day of the exhibition is subject to a theme specified by Messe München GmbH. For the days

4 Terms of payment

Payment in full of the participation fee before the start of the exhibition is a prerequisite for occupancy of the transport logistic Campus Plaza.

The amounts invoiced in all invoices issued by Messe München GmbH in connection with the event are to be transferred in euros, without deductions and free of all charges to one of the accounts specified in the respective invoice, indicating the customer number. The times of payment specified in the invoices are binding and are to be complied with.

Messe München GmbH can issue invoices only to its contractual partners.

Should the participant wish to have an invoice re-issued because the name, legal form or address of the invoice recipient has changed, the participant is bound to pay Messe München GmbH a fee of **EUR 50** for each invoice amendment, unless the data included in the original invoice in respect of the name, legal form or address of the invoice recipient was incorrect and Messe München GmbH was responsible for the incorrect data.

The final invoice for additionally ordered services will be sent to the participant approx. 6 weeks after the event; it is payable immediately upon receipt.

5 Stand construction, design and equipment

The transport logistic Campus Plaza has a uniform stand design, which is specified by Messe München GmbH/transport logistic project management. The areas in which company logos may be displayed are determined by Messe München GmbH. The company provides its logo in the form of a printable PDF or vector file and agrees that the graphics may be used by the stand constructor commissioned by Messe München GmbH in the designated areas of the stand as well as by Messe München GmbH on <https://transportlogistic.de> and in corresponding advertising materials. The approval for the use of the logos is limited to the transport logistic Campus Plaza 2025.

Due to limited space, it is only permitted to bring along 1 roll-up, flyers and presentation media such as laptops, tablets, booklets are permitted. The placement of prototypes is only allowed after prior coordination.

6 Contract cancellation

In the event of the participant being unable to make the agreed use of the participation at the transport logistic Campus Plaza for reasons for which he is responsible, he is as a general rule obliged to pay the agreed participation fee. The same applies if the participant is unable to make the agreed use of the participation at the transport logistic Campus due to force majeure or reasons for which Messe München GmbH is not responsible. If he notifies Messe München GmbH of his inability to make the agreed use, then the following arrangement applies in respect of the compensation to be paid depending on the point in time at which notification is received prior to the official start of the trade fair:

Receipt of notification
up to eight weeks prior to start of trade fair: **25%** of the contractually agreed participation fee

up to six weeks prior to start of trade fair: **50%**

any time thereafter: 100%.

Messe München GmbH will set off the value of the expenditure saved as well as that of the advantage gained from any other usage made of the object concerned in the ratio of the reduced participation fee as per the aforementioned tiered system to the contractually agreed participation fee.

7 Place of performance, applicable law

If the participant is a trader, a legal person under public law or a special fund under public law, Munich is the agreed place of performance, for all financial obligations too. German law applies exclusively.

8 Jurisdiction

If the participant is a trader, a legal person under public law or a special fund under public law or has no general place of jurisdiction in the Federal Republic of Germany, Munich is the agreed place of jurisdiction. Messe München GmbH

is also entitled, if it so wishes, to assert its claims against the exhibitor at the court in the place of jurisdiction in which the participant's registered head office or branch office is located.

9 Data protection

Personal data which is collected on or transmitted by the participant may be used for the fulfillment of the business purposes of Messe München GmbH within the framework of the statutory data protection provisions. The participant shall establish the preconditions required under data protection law to enable the above uses by means of appropriate measures (e.g. obtaining con-

sent of his employees). The participant is liable to Messe München GmbH for damages and expenses resulting from the infringement of this obligation and shall hold Messe München GmbH harmless from any third party claims upon first demand.

10 Severability clause

Should the provisions set out in the Terms of Participation be invalid or incomplete, the validity of the other provisions and that of the contract remains unaffected. In such cases, the contracting parties undertake to replace the

invalid provision and/or fill the gap with a provision with which the contracting parties are most likely to achieve the economic purpose they pursue.

11 Photo, film and video shooting (cf. A 10)

In deviation from A 10 of the Conditions of Participation A, approval for photography, filming and video recording of the exhibitor's own stand is no longer required during the official set-up and dismantling times, or during exhibitor opening hours.

Written permission is now only required outside these times (i.e. during night closing times) and is compulsorily linked to the booking of an accompanying security guard. All information on this will be published in the Exhibitor Shop in the relevant leaflet.

The use of drones is expressly prohibited at all times (set-up, running time, dismantling).

12 Advertising

The following provision replaces clause A 11:

No advertising activities, including the deployment of stationary and mobile advertising carriers, promotion teams or the distribution of printed media and food samplings may be conducted at the fairgrounds outside the confines of the given exhibitor's stand, unless the exhibitor has applied for and obtained authorization from Messe München GmbH for such activities, which are subject to a fee. Messe München GmbH is entitled to stop unauthorized advertising activities outside the confines of the rented stand, in particular to expel persons

who are used as advertising carriers from the site, and to confiscate, remove or destroy unauthorized advertising media. Messe München GmbH is entitled to demand a compensation in the amount of **EUR 5,000** for unauthorized advertising activities carried out by the exhibitor outside his stand, or by third parties commissioned by him, amounting to twice the fee Messe München GmbH would have charged for granting approval. Messe München GmbH's right to claim further damages remains unaffected.

13 Background noise, sound effects during the event

Video, music, product and show presentations (band, background music, DJ or similar) during the trade fair (see opening times) are limited to a **maximum duration of 15 minutes per trade fair day** and must be carried out in such a way that neighboring exhibitors are not disturbed. Accordingly, loudspeakers and other acoustic amplifiers/sound systems must be focussed on the exhibition stand and may not sound off on neighboring stands or aisles. The maxi-

mum permitted noise level for performances may not exceed **70 dB (A)** at the stand perimeter. Messe München GmbH reserves the right to limit or prohibit demonstrations of any kind causing noise, optical disturbances or representing a hazard or impairment to the event and especially to event participants for any other reason. The relevant statutory provisions must be observed.

14 Value-added tax

The charges set out in the Terms of Participation are net amounts. Insofar as they are subject to German value-added tax in accordance with sales tax legislation, the fees concerned are charged plus German value-added tax at the rate valid at the given time.

15 Alterations

Messe München GmbH reserves the right to make alterations and additions in matters affecting technical handling and safety.
