

## Form Different Invoice Recipient

We have registered for the DMEA 2027 and herewith request that Messe München GmbH, Am Messesee 2, 81829 Munich, Germany, sends its invoices not to us but to the invoice recipient designated below. We are aware that, in particular for reasons of value-added tax legislation, this is only permissible if the invoice recipient named below is the contractual partner of Messe München GmbH, instead of us.

We therefore declare:

All representations under the contract with respect to our planned participation in the DMEA 2027 and other services which we order from you in connection with our planned participation in the DMEA 2027, are made on behalf of the invoice recipient named hereafter. This also applies to representations under the contract which we have already made. We certify that we are duly authorized to do so.

We agree that any contracts regarding our participation in the DMEA 2027 and other services related to our participation in the DMEA 2027 shall be concluded in such way that Messe München GmbH renders the services due under the contract to us (third-party beneficiary contracts).

We warrant that the invoice recipient named below shall duly and promptly meet all obligations arising from aforementioned contracts with Messe München GmbH. This also applies mutatis mutandis in case one of the aforementioned contracts should be void due to lack of authority or approval by the invoice recipient.
