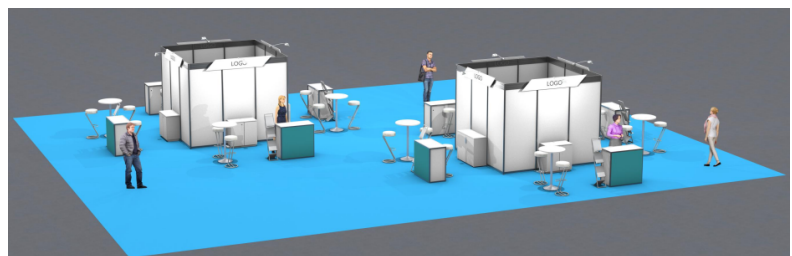

## **Rental conditions for full-service stand package „Shared Booth Camping World“**

1. No pro rata reimbursement will be made for items included in the basic equipment that are not required by the exhibitor. These items can only be offset in consultation with the stand builder and, if necessary, by means of a separate invoice between the stand builder and the exhibitor.
2. All parts delivered are rented. The rental equipment is usually used several times and is therefore not always in mint condition.
3. During the rental period, the renter and his vicarious agents are responsible for the rented equipment. The renter is liable for theft and all damage to structural components and furnishings under civil and criminal law.
3. During the rental period, the renter and his vicarious agents are responsible for the rented items. The renter is fully liable under civil and criminal law for theft and all damage to construction elements and furnishings. Damage to the stand construction and theft of parts must be reported to the lessor immediately after becoming known. Damaged walls will be charged at a unit price of EUR 50.
4. Cabins and lockable furniture are not burglar-proof. The locking mechanisms serve solely as a visual barrier. It is therefore strongly recommended that stand security be ordered (via the exhibitor shop). Exhibitors are also strongly advised to insure both the entire rented property and exhibits or similar items in an appropriate manner (value approx. EUR 500 per sqm of stand construction, via the exhibitor shop). Fairfellows GmbH and Messe München GmbH are not liable for items left at the stand.
5. The stand will be handed over on the last day of construction before the start of the event. If the lessee wishes to arrange a different handover date, they must notify the lessor in writing. Any changes to the handover date must be confirmed in writing by the lessor.
6. The lessee may not make any structural changes to the rented property or stick anything to the walls, nail anything to them or damage them in any other way. The removal of adhesive residue will be charged to the lessee at cost.
7. If ordered items are no longer in stock, we reserve the right to deliver comparable items or items of a higher quality.
8. The stands must be dismantled immediately after the end of the trade fair. The exhibition stand must be left empty after the end of the event. Cabins must be emptied, and cabin doors must not be locked. The lessor accepts no liability for any items left on the exhibition stand.
9. The keys remain with the lessee for the duration of the rental period. For opening booths, etc. due to forgotten or lost keys after the booth has been handed over, the lessee will be charged a flat fee of EUR 50. After the end of the trade fair, the keys must be left in the respective locks.  
Lost keys will be charged at EUR 50 per key.
10. Subject to the applicable statutory provisions, the contract may only be terminated (cancelled) under the conditions described below, unless such termination is already regulated or excluded by other (event-specific) agreements. The customer who cancels their order without being entitled to a right of withdrawal shall be obliged to pay compensation for expenses amounting to 75% of the order value up to two weeks before the start of assembly and 100% of the order value thereafter. Only cancellations in writing shall be deemed to have been made in due time. The customer shall bear the burden of proof that written notification was received in good time. However, we shall be entitled to offset the value of the saved expenses and any benefits we obtain from other use of the services. The customer may demand a reduction in the compensation for expenses if he proves that we have incurred only minor expenses. We are entitled to withdraw from the contract if the customer has not made payments due under this contract, we have requested payment from the customer, setting a grace period of five days, and payment has not been made within the grace period. We are also entitled to withdraw from the contract if the customer violates an obligation arising from this contract to respect the rights, legal interests and interests and if adherence to the contract can no longer be reasonably expected. In all of the above cases in which the customer has caused the reasons for the declared withdrawal, we reserve the right to assert further claims, in particular claims for damages.
